<ul style="list-style-type: none"> A study, exchange visa to China (F-Visa) is granted for the purpose of (1) attending conference (2) academic exchanges (3) cultural exchanges (e.g. non-profit performances); religious exchanges; (4) NGO activities; (5) volunteering (90 days or less) (6) foreign expert with approved letters of invitation; (7) geographic surveying and mapping activities. Single-entry visa is valid for 3 months and double entry is valid for 6 months. The visa validity and the period of stay allowed are 2 different entities. If you are applying with a new passport transfer the status of the re-entry from the cancelled passport to the new passport before uploading. <ul style="list-style-type: none"> Upload the expiry and validity status of the Work and Related passes which can be obtained by scanning the QR code on the work pass using the free SgWorkPass app available from Goggle Play Store or Apple App Store to obtain the latest pass information. <ul style="list-style-type: none"> Upload a personal letter if you have travel to Pakistan specifying the purpose of your visit to Pakistan, exact dates of entry and exit, duration of stay, a photocopy of all Pakistan entry and exit stamp. For naturalized Pakistan citizen a CLEAR copy of the Pakistan ID (front and back) must be uploaded.
