

CHECKLIST to CHINA family Visit Visa (Q-1)

<ul style="list-style-type: none"> A family visa to China (Q2- type) is issued to those who are family members of Chinese citizen who intend to visit China for long term family reunion (the intended duration of stay in China exceeding 180 days but NOT MORE than 365 days). Family members refer to spouses, sons, daughters, brothers, sisters, spouses of son(s) and daughter(s), grandparents, grandson(s), granddaughter(s) and parent-in-law. Single entry is valid for 3 months, double entry is valid for 6 months and multiple entry is valid for 12 months except for passport holder of (USA, Canada, Israel, Brazil and Argentina; 10 years multiple entry visa will be issued). The visa validity and the duration of stay allowed are 2 different entities. If the review shows 'Approved' you will receive an email confirmation. (B) Birth Certificate (C) Citizenship renunciation notification (D) Cancelled passport returned to Chinese embassy confirmation.
