<ul style="list-style-type: none"> A Medical Tourist visa is granted to foreign patients who wish to enter South Korea for medical treatment or recuperation or a caregiver of a patient. Single entry is valid for 3 months, double entry is valid for 6 months and multiple entry is valid for 5 years. Visa validity and duration of stay allowed are 2 different entities. Enter Korea within the validity of the visa otherwise; the visa will lapse. <ul style="list-style-type: none"> Print the validity and expiry status of your work pass by scanning the QR code on the work pass using a free SgWorkPass App (available on Goggle Play store or Apple Appstore) to obtain the latest pass information.
